The Clerk reported that the Parish Council's response had been submitted to the Borough Council on the Local Plan Consultation.

AMENITIES

The Parish Council will carry out daffodil planting in the Autumn.

The Clerk was asked to contact Severn Trent to investigate a blocked drain on Far Street and obtain quotations for the renovation of the bench on the A60.

Pedlars had recently been active in the village. Residents are reminded that all legitimate pedlars must, by law, carry a Pedlar's Certificate. Anyone wishing to do business with them should always check the details on the certificate.

A parishioner had raised concerns regarding irresponsible parking at, or near to, road junctions and blind bends in the village. The Council decided that there was very little they could do other than to highlight the problem to residents by including a note in the Village News.

Dog faeces continue to be a problem along Main Street and Far Street.

FOOTPATHS

Cllr Colwill reported that Moor Lane had been greatly improved by the repair work which had cost Notts CC several thousand pounds. Comments had been received on the legibility of the fingerposts. If replaced, Notts CC would do so with metal ones. The Parish Council agreed to retain the fingerposts for as long as possible.

Steven Adams, the NCC Broadband Engagement Officer gave an update on superfast fibre broadband. Copies of all Speakers' reports are available from the Clerk.

No volunteers had come forward to organise the "Best Kept Village" for the 2017 competition.
