CORRESPONDENCE

Nottinghamshire County Council resolved at its meeting on 25 May 2017:

- That the County Council withdraws the draft Minerals Local Plan from Examination;
- That officers are instructed to carry out an immediate review of the methodology used to assess need for aggregates in the draft MLP taking into account the most up to date data available;
- That officers are instructed to prepare for the submission of a revised draft Minerals Local Plan.

A presentation was given at the Rushcliffe Borough Council's Town and Parish Conference on 16th June by the New Monitoring Officer on the Code of Conduct for Councillors.
