Mr John Scott-Lee, Managing Director of Streetwise, gave an interesting and informative talk on the aims and objectives of Streetwise. Streetwise was recently devolved from the Borough Council in order to make its operations more cost effective and also to enable it to operate more competitively in the commercial world. It is split into five divisions – Environmental, Landscaping, Playgrounds, Trees and a Direct Learning scheme which is designed to give training to the unemployed with the possibility of full time employment in all aspects of their work.

Residents again voiced concerns regarding vehicles travelling at inappropriate speed through the village. Roads are very narrow and, by necessity, there is a great deal of on-street parking. There are also several blind corners and areas with no footpath. For these reasons, travelling at a speed considerably less than the 30mph legal limit would seem to be more sensible.
