NALC

A welcome letter to new and returning Councillors had been received from the Chairman, Ken Browse.

The independent Local Government Boundary Commission for England is asking for people across Nottinghamshire to comment on its draft proposals for new County Council division boundaries. **A 9 week public consultation on the recommendations began on 9 June and will end on 10 August 2015.** Anyone can have their say on new County Council electoral divisions, division boundaries and division names across Nottinghamshire. British Gypsum were conducting a trial along the A60 in response to complaints of noisy lorries in the early morning. Fernwood had agreed to a voluntary curfew of 30mp, not travelling in convoy and, where possible, would avoid sending empty wagons along the A60.

Mr David Archer had written to thank the Clerk and the Parish Council for their help in correcting the planning oversight by RBC over 18 years ago for the conservatory and replacement windows.

The Local Government Boundary Commission were asking for comment on draft proposals for new County Council division boundaries with a deadline of 10th August.

VISIBILITY MIRRORS

Residents had suggested the siting of visibility mirrors on blind corners at each end of Farmer Street (near the junction with Manor Farm Close and near the junction with Main Street). The Highways Department would not permit this on Council owned land. Cllr Adair added that both the landowner's permission and planning permission would be required if an individual wished to pursue the matter.
