#### **CORRESPONDENCE**

The Rushcliffe Local Plan Part 1: Core Strategy was formally adopted by Rushcliffe Borough Council at its Council meeting on Monday 22 December 2014. See <a href="https://www.rushcliffe.gov.uk/planningpolicy">www.rushcliffe.gov.uk/planningpolicy</a> for further details.

DCLG have published the Transparency Code for smaller authorities, which is issued initially as "recommended practice", with the intention of making the code mandatory by the start of the 2015/16 financial year.

The Parish Council had written to the Highways Department concerning the traffic congestion at the Business Park roundabout. Nottinghamshire County Council responded to the effect that, as there had only been one vehicle collision involving a single vehicle losing control on ice within the period 01/01/2011 to 30/06/2014, this represented a good accident record and therefore did not justify a major scheme. The eventual solution sometime in the future may depend more on upgrades to the surrounding major A road routes as an alternative to the A60.

A resident had written to the Parish Council with concerns about the planning application on Asher Lane, Ruddington. 146 Ruddington residents had met in St Peter's Rooms, Ruddington, to voice their objections.
