CASUAL VACANCIES

A second Casual Vacancy has arisen on the Parish Council due to the resignation of Kathryn Buksmann. Cllr Colwill gave thanks for her contribution over the past 18 months. The Clerk has informed Rushcliffe Borough Council of the vacancy and a notice has been placed on the notice boards. If, within 14 days of the date of the notice, 10 electors from the Parish make a request in writing to Rushcliffe BC, for an election to fill the vacancy, then an election must be held. Otherwise, the vacancy may be filled by co-option. Once the statutory period for electors to request an election has ended, the Parish Council will notify parishioners, and interested individuals will be invited to apply for co-option to the Council.
