Chairman's Report

All organisations benefit from a change of leadership from time to voluntary organisations set a limit of three years in post for the Chairman. After four years as Chairman, which followed three years as Honorary Secretary, I will not be standing for election again at the AGM in March. I am grateful for the help and support of the membership, especially Committee members, past and present.

The challenge for the Committee is to find a new Chairman. None of the existing Trustees is in a position to take on the role of Chairman. We need a local person, preferably an existing member of the Trust, with the long-term interests community at heart, who is able to be a figurehead and a focus for the Trust.

It is a role with responsibilities, but is not too demanding because the Committee and other Trust members are very willing to take on much of the work. The challenge for the new Chairman is to ensure that the Trust continues to look forward and to be effective.

The Trust faces challenges in meeting its aims. Our past successes include persuading Wiltshire Council to recognise Devizes needs infrastructure before vet more housing estates and awakening the Council to the air quality problems of the town centre.

These successes have been achieved by working with other community-minded organisations and with the public. On the other hand, we have not ended the

Our Broken Planning Sytem

For over two decades, Devizes has had housing developments which have not been planned but have been imposed on us by developers who have not been interested in the needs of our community. As a result, we now lack the essential infrastructure needed to cope with the increased population: green health facilities, local employment, cycle routes, etc. Because Devizes' roads are very congested, we have the kind of air quality problems that normally occur in major towns and cities.

The planning system has complex and obscure rules which produce absurd results. Planning decisions have to meet criteria which bear little relationship to local needs and land speculators dictate what is to be built and where. If the local refuses planning authority permission, the speculator can appeal.

Speculators have deep pockets and employ the best legal advisers to win appeals. They can even be awarded costs, which penalises the council tax payers. That happened

recently for the so-called Care Village at Quakers Walk. To add the to injury, speculators have not laid a brick after more than two years and apparently want to sell the site to realise their gains because of its greatly increased value.

Planning appeals are decided by a planning inspector, appointed by the Government, with a strong bias towards finding reasons for developments. allowing planning rules contain favour presumption in "sustainable" development. That allows the speculators to drive a coach and horses through logical local plans.

"Sustainable" is a nonsense word which implies that we can forecast the future and assumes that there will be no changes to our assumptions and no unexpected unintended consequences. Forecasts become less accurate as they go further forward because of uncertainties. What considered sustainable today can become a liability tomorrow.

Latest developments



All that remains of the garages

We have been in correspondence with Councillor Sue Evans following the demolition of the garage on land behind the Assize Courts. This would appear to be a useful step forward in providing parking space associated with the development.

Mrs Evans replied as follows:

"The land in question was inherited by Mr Merrett's family (who are not local) However, for many years after it ceased use as a garage the family did not do anything with it. There were sale boards up and it was theoretically on the market but any approaches (and there have been various attempts to contact the family) have met with a negative response. Then in 2012 the building partially collapsed and we were involved in making sure it was made safe. The building was finally demolished fairly recently.

"Wiltshire Council are keen to ensure that any scheme which comes forward for the site does not prejudice the development of the Assizes Courts. Wiltshire Council have also advised the owners' agent that they may wish to consider liaising with the owners of the Assize Courts (Wiltshire Council have provided contact details etc) If the family do not want to sell and instead to pursue application themselves Wiltshire Council have no remit under which to insist that the site is developed in conjunction with the Assize Courts.

"This site clearly has a commercial value and I very much doubt that the family will wish to sell the site at a price which would make economic sense to purchase for car parking."

While this is a helpful reply, it does not take us any further forward as far as the development of the Assize Courts is concerned. The Trust will continue to do whatever it can to press Wiltshire Council to take a more positive approach to rescuing this historic building.

Our Broken Planning System

A year ago, a delegation from our area met with Devizes MP Claire Perry and the Housing Minister. The Minister assured us that we could control developments through a local Neighbourhood Plan, provided that the Plan did make provision for houses.

Devizes, Roundway and Bishops Cannings joined forces to create a Plan and quickly identified ample sites to meet our imposed housing quotas. These sites are mostly brownfield and within walking distance of the centre of Devizes to reduce urban sprawl and to minimise traffic. Brown-field sites are ignored by developers because they cost more to build on and reduce profits.

Meanwhile, the Government is delaying the final approval of the new Wiltshire core strategy and our Neighbourhood Plan by various bureaucratic tactics. That has allowed two developers to cynically submit planning applications for large unwanted housing estates on greenfield sites.

Wiltshire Council felt forced to accept one proposal, Lay Wood, along the Horton Road, for fear of having a big bill for developer costs. The other proposal, Coate Bridge, will be the subject of an appeal. We await the outcome with interest and concern.

Taking the next steps

In June and September last year, business owners, town councillors, long residents term and newcomers to Devizes were amongst those who attended lively debates about the future of the Devizes and in particular there was a key theme to the suggestions on what could be done to improve the town centre and manage its use for the benefit of all.

There were two issues that stood out which gained universal support: that there is a need to reappoint a Town Centre manager and the need to improve the streetscape of the Market Place and the Brittox.

The Trust is committed to pursue these objectives by bringing together all interested parties to establish a plan to champion some of these issues and lobby for the establishment of a Town Centre Manager.

The Town Centre Manager would coordinate and manage improvements to Devizes Community area within the Town.

Changes and improvements to the the Market Place, The Brittox and The Shambles are seen as key to creating a more visitor-friendly aspect to the town while maintaining the historic character of the town centre.

The Trust will be approaching the Town Council, Wiltshire Council, Devizes Chamber of Commerce retailers & business operators and market traders to seek their support in this. We will keep you informed on progress in the next issue of Trust News.

The Lacock Cup

A notable acquisition

The British Museum and Wiltshire Museum have jointly acquired the Lacock Cup, one of the most significant pieces of secular English medieval silver with support from the National Heritage Memorial Fund, the Art Fund and private donations.

Dating from the mid 15th century, the Lacock Cup is an English silver and partially gilded drinking cup which has been owned by the Church of St. Cyriac in Lacock, Wiltshire, and used by its congregation for over 400 years.

It has been on loan to the British Museum since 1963 and until the 1980s continued to return to the church to be used as a chalice for certain religious festivals.

Identical copies of the Cup will be made out of silver by the British Museum's metalworker for the Wiltshire museum and St Cyriac's church, which will once again have a magnificent silver goblet for communion services.
