## Land at Coate Road - new proposals

has recently received a letter from Pegasus Planning Group with the news that they are preparing a planning application for outline planning permission for the development of land at Coate Road Devizes for housing. The letter goes on to say that before the planning application is finalised for submission to Wiltshire Council, they are seeking the views and comments of the local community.

Some of our readers will remember that a previous planning application for this site was dismissed by Eric Pickles, the Secretary of State for Communities and Local Government in October 2014 after a long and difficult local campaign. Claire Perry, our MP at the time, our county and town councillors. the members Neighbourhood Planning team and many local people were involved in the successful campaign.

The site for the proposed development is to the north east of Devizes, immediately to the north of Coate Road and to the south of the Kennet and Avon Canal. The new proposal provides for around 255 residential units, with dwellings fronting the canal. The 2013 application was for 350 dwellings, but history suggests that, once outline permission has been granted, the numbers might well be increased.

The Trust objected to the previous application on several grounds, but most importantly we pointed out that the application was not within the former Kennet District Council's designated area for Devizes development nor was it within

Not unexpectedly, Devizes Town Council areas proposed for development in the emerging Wiltshire Council Core Strategy

> It would have been an extension of the continuous urban area of Devizes onto outlying greenfield areas and would bring the outlying village of Coate closer to incorporation into the Devizes urban area. It remains the case that the area involved is not within the Devizes Neighbourhood

> The Trust Committee will be considering our response over the next few weeks. We urge you to look at the website which contains more detail about the new application and is available here

## Devizes Between The Wars

Following our article about the town criers in the last Trust News, we have received the following memories from Jim Page, now of Bradford-on-

Having been born and brought up in Devizes in 1930 I remember after Mr Dowse retired a bench was bought with a small metal label on the back in his memory. It was set up, together with one for my parents, William and Mary Page, outside what was then Handel House, a significant piano and music shop. My parents' bench was later moved to an area by a secondhand bookshop off the Little Brittox, I don't know what happened to Sidney Dowse's bench.

On another matter from the previous Trust News you asked for any photos of sub post offices. I can't provide photos but have strong memories of Townsends post office, having lived in Mary's Cottage opposite the Black Horse pub. It was run by Derek and Ralph Townsend under their father whose name escapes me, together with their sister Audrey. The last collection (this would be prewar) was 6.0pm . I would often rush round at about 5.55pm to post for my father to be greeted by "Them that's nearest is always last!"

We lived immediately opposite the Black Horse and one day my older brother, aged about 14 noticed smoke coming from the pub. He promptly phoned the Fire Brigade. The pub owner Mr. Eden was cross because he said he could put the fire out, and didn't like the publicity as he was a prominent councillor at the time.

With regard to the bench in memory of my parents, it was labelled William and Mary Page residents of Devizes 1918-1981. They came to Devizes newly married at the end of the war when my father was severely wounded losing both legs, and my mother was the last to die in 1981.

# Air Quality

An update from Philippa Morgan, who represents the Trust on the Devizes Air Quality Steering Group

One of the benefits of Covid 19 has has met on Zoom during 2020 and will been the improvement in air quality as people have driven less and flights have reduced drastically in number.

In the Devizes area, we are now in Band 1 of the banding system approved by the Committee on the Medical Effects of Air Pollutants (COMEAP). This means that the effects of air pollution in Devizes are unlikely to be noticed even by those who are sensitive to air pollution.

It is obviously good news for those with heart and lung diseases, including asthma, and it means that we should be able enjoy outdoor activities without worrying about its effects on our health.

The challenge that we face is for the level of air quality to remain low when travel restrictions are relaxed and there is greater freedom to travel.

The Devizes Air Quality Steering Group

be responsible for local implementation of the latest Wiltshire Air Quality Strategy as it develops.

Some of the challenges we face as a county are the higher than average car ownership due to the region's rural nature, the need for more housing and economic growth and our poor access to public transport.

The Devizes Action Plan which was written in 2015 is now due for an update. Some of the aims of the Action Plan have been achieved with improvements to the towpath, support of cycling routes and greatly increased home deliveries by supermarkets.

The Steering Group will review the action plan in coming months with a view to setting objectives and targets for the next five years.

# The Planning White Paper

The Trust's response

Government's process. This is a summary of the comments we made:

In the Trust's view, spatial planning should be primarily a function of local government, with most policies and decisions taken locally, by a local democratic process. Central policy and decision making should be limited to setting a consistent framework, setting strategic scale and distribution of development, and avoiding inconsistencies and anomalies (eg postcode lottery).

It is crucial that important decisions on the sustainable development of our cities, towns and countryside are taken democratically, and as far as possible. locally. Democratic accountability is more important than speed.

We support the Paper's focus on design and quality, but the proposals seem disjointed, rather than offering a coherent strategy. Energy efficiency should be a key objective of the drive to improve design and quality.

This objective should be included in an update/upgrade of the Building Regulations. It is likely to bring better design and better materials with it.

It would be a mistake to break the link between development and infrastructure. Although there are administrative advantages treating the infrastructure levy as a flat-rate tax, it is important that communities particular see developments providing individual items of infrastructure

The Trust has recently responded to affordable housing. We need more consultation housing, but it should be in better. more sustainable locations (where jobs are) and a better mix, determined chiefly by affordability.

> Planning should encourage the of genuine strategic selection locations for growth (eg Swindon), and discourage the present practice of 'smearing' housing development across smaller towns (like Devizes).

> The process should be driven by coherent spatial strategies, not by 'predict and provide' inertia. We need a proper democratic process to identify 'growth', 'renewal' and 'protection' places.

> accept that household projections are still the 'least bad' basis for housing strategies. But they need to be moderated at the local level, particularly to relate better to the distribution of jobs, and to take better account of affordability.

> We conclude that there are some good and some not-so-good proposals. It is all rather unfocused, and looks more like a wish-list than a strategy. Difficult decisions will be needed as the reforms move forward.

> The government should make sure that 'build better' does not lose out out to 'build quickly'. The reforms will need a major new Planning Act.

> Incidentally. we note that the Government is proposing to reinstate national top-down targets, vears after Eric announced that he was scrapping them on 6 July 2010!

### The Devizes Assize Court Project; an Update

Following a nationwide competition which attracted many high-quality submissions, the Assize Court Trust has appointed Purcell, an award-winning architectural practice based in Bristol.

Purcell are developing ideas for the restoration and adaptation of the historic Assize Court as well as planning a new extension fronting onto the Kennet and Avon Canal. The brief for the architects outlines requirements for exhibition galleries, café, shop and museum storage as well as community spaces, including meeting rooms and a large event and lecture space.

Additional work will be undertaken to identify how the building will be used for education, as a venue for local people for functions and perhaps weddings, and for tourists who can learn about the history of Wiltshire and the Assize Court itself as they sit in the very place in which trials for the misdeeds of some of its citizens took place.

It is intended that this regeneration will help to put Devizes on the map as an important destination for tourists.

# St Mary's Church Project



Since the last edition of Trust News, we have managed to reach an agreement with the St Mary Devizes Trust that the refurbishment of the church's two sets of Grade II listed gates will be included in the development project. We were concerned that the gates had not been specifically included in the project, and we have now been assured that they will be dealt with as part of the overall scheme.
