#### **Chairman's Report**

Planning matters are still a concern. The planning application for a large new housing estate adjacent to the Road is still under Coate consideration. There is a serious oversupply of new housing in the Devizes area which has caused huge strains on the local infrastructure. For example, the traffic problem has caused serious air pollution in the town centre and the local GP surgeries overloaded. Α new development would add to traffic problems on London Road and much of the commuter traffic would seek rat-runs through the inadequate lanes through Coate to Horton Road. Trust and other The organisations have submitted objections.

Crown Estates is a government organisation that owns land to the North and West of Devizes. It has proposals for a housing estate on the Horton Road, an extension of the new housing there. That location would be better than Coate Road for traffic flows in and out of the Town, but it could still be too many new houses for us to cope with at this time. We are also concerned about the effects on the Lay Wood nature reserve and we shall be objecting to the proposal.

years ago to nudge Wiltshire Council into taking the problem of local air pollution seriously, and there were accusations that were being aggressive. Wiltshire Council has yet to propose any real solutions. The Wiltshire Traffic Strategy for Devizes: more cycling, tinkering with road junctions and trying to improve public transport at little or no cost, is not an answer. A recent test case in the Supreme Court threatens the UK Government with large fines for exceeding air pollution limits. We will end up paying through our taxes of course. That is a consequence of ongoing serious failures of planning at all levels.

#### The AGM March 2013

We had changed the format of the meeting for this year to minimise the formalities. The public meeting and the guest speaker was the first item and we began the AGM afterwards. The Chairman briefly reported on some current events and we produced a printed Report and Accounts for the year to the end of 2012. We would welcome members views.

## Air Pollution and the Wheels of God

All sorts of things emerge when you are moving home! As I was clearing out my study I came across a copy of Trust News dated August 2011. It was a memorable issue for me as it reported on the success of our 'No More Houses' rally and gave a detailed account of the Trust's concerns about the high level of air pollution being experienced at various places in the town centre.

I believe that it was the rally and that issue which pushed Wiltshire Council into dealing with the issue of pollution in a more serious way than hitherto. I had several meetings with the Council's Public Health Department and there were definite indications that action would follow. Sadly, my optimism was to prove unfounded. Whoever it was who said 'the wheels of God grind exceeding slow' had not had dealings with Local Government!

Progress has been made as far as the Council is concerned and, indeed to a limited extent that is true. The Air Quality Management Area (AQMA) which existed in 2011 around Shanes Castle has been replaced by one which runs the length of the A361 and takes in the whole of the town centre. Also a Steering Group has been set up to produce a plan to reduce pollution. So far so good you might think.

A closer examination of the facts indicates that most progress has been made in moving the goal posts, so to speak. Whilst the EU law is explicit, Government have to act to reduce pollution where it exceeds what the and the World Organisation consider a safe level (as it does at seven monitoring points in Devizes), the UK Government allow Councils three years to achieve this once an AQMA has been declared. Shane's Castle was declared in 2010 so is the year when action had to be taken. However, the Shane's Castle AQMA has been rolled into the new Devizes AQMA and so the three years can start again from the end of 2012. I don't call that progress!

The Steering Group is moving painfully forward and still does not have an agreed plan for reducing pollution. A Task and Finish Group, set up to determine what actions could be taken to reduce car use decided that the subject of commuter parking was off-limits, presumably because it is seen by politicians as a 'hot potato'. Any activity to reduce traffic has to be viewed in the light of Government forecasts which predict a 20% plus growth over the next 15 years. In my view nothing should be ruled out; everything should be examined and then decisions made as to where to take action.

What may galvanise the Council is a ruling last month by the Supreme Court that the Government was failing in its legal duty to protect citizens from the effects of air pollution, thereby underlining the force of the EU regulation. On the face of it, this opens up the way for the EU to impose huge fines and also for people who suffer as a result of air pollution to sue the Government.

There is ample evidence (much of it detailed in my article in 2011) that air pollution damages people's health and shortens life expectancy. My main concern in all of this is that the health issue, which is surely the most important, is hardly ever mentioned; rather officials prefer to talk about objectives and strategies.

Despite the lack of progress so far, I am hopeful that this latest legal development and the increasing threat of large EU fines will instil a degree of urgency into the debate. However, whether the wheels of local government can overtake those of God remains to be seen.

## **Devizes in the Media**

Over the years, Devizes has had its fair share of coverage in films and on television. As well as the obvious human interest, these also provide a valuable insight into the way that our town has changed over the years. What follows is a list of those of which I am aware. If anyone knows of any features which I have missed, please write and let me know.

Probably the most well known movie which features Devizes is 'Far from the Madding Crowd'. The film, which is based on the Thomas Hardy novel of the same name, was shot in 1967 and starred Alan Bates, Terence Stamp, Julie Christie and Peter Finch. Filming took place in the Bear Hotel and the Corn Exchange, then in a more original state, with Devizes cast as 'Casterbridge'. The Market Place was also used for a fair. On piece of trivia is that Dave Swarbrick, later of Fairport Convention, can be seen playing a fiddle during the barn dance scene. The film is occasionally on one of the TV channels but can also be obtained from the usual outlets.

In 1962, Poet Laureate John Betjeman made six television programmes, each eulogizing the buildings of a different town. Three programmes retain the original soundtrack, whilst Nigel Hawthorne narrates on the others, drawing from Betjeman's original script. The areas looked at are: 'Swindon and Lew'; 'Chippenham North Crewkerne'; 'Devizes'; 'Sherborne'; 'Sidmouth'; and 'Bath'. Copies of the DVD containing these programmes can be obtained from Devizes Books for £14.99.

The late Alec Clifton-Taylor was a much-respected architectural historian and writer. As a broadcaster, he presented a number of successful television programmes for the BBC. One of these was 'Six English Towns' which ran for three series' between 1977-1984. One of the programmes, broadcast on 30 September 1984, centred on the town of Devizes. Throughout the 30 minute programme, Clifton-Taylor is seen visiting all the town's many historical

buildings and landmarks including Devizes Castle, St James's Church, The Bear Hotel, the market and Corn Exchange and Wadworth Brewery. At each point in his journey he reflects on the history of each location and ruminates on the town's varied architecture which stems from the Norman period to Georgian and beyond. Another programme on the BBC's website is 'Day out in Devizes'. This was filmed in 1977 and stars possibly the most well-know man in Devizes at the time - Sidney Dowse. He'd been town crier, mayor's secretary, official aletaster, keeper of the town's treasured regalia and swimming baths manager. The full programme can be seen here.

## **Planning News**

A roundup of major issues

#### **Assize Courts**

Despite planning permission being granted in May 2012 to turn the building into flats, work has not yet started and the building continues to be an eyesore. The Trust has tried to contact Gatewell Ltd, the current owners, but to no avail. We raised the issue at the recent Community Area Board meeting and are awaiting a response from Wiltshire Council.

#### **Quakers Walk Care Village**

Outline planning permission was granted on appeal in November 2012 since when the 11 acre site has been marketed by estate agents Carter Jonas. As far as we are aware, the land has not yet been sold.

#### St Peter's School, Bath Road

The former St Peter's School site was one of the sites included in the recent consultation exercise carried out by Devizes Town Council for the Neighbourhood Plan. The site would accommodate up to 21 homes.

#### Devizes Car Centre, New Park Street

This land, formerly a petrol station, has been identified by Wiltshire Council as 'land allocated for development' and is now for sale through Hamptons International.

#### **Browfort**

The former Wiltshire Council office building is also for sale through Bruton Knowles Residential. Bruton Knowles are inviting 'expressions of Interest for the whole site or any part thereof'. The Gazette and Herald reported in November last year that the buildings could be demolished to make way for homes.

#### **Crown Estate - Lay Wood**

Following the recent public exhibition outlining the proposed development, the Trust hopes to meet with the developers to present our detailed comments on the plans.
