#### Chairman's Report

We have led some successful campaigns against unwelcome developments but we also want encourage good developments and we support the current efforts by Devizes, **Roundway and Bishops Cannings** Councils to develop a joint Neighbourhood Plan. The need for that plan is urgent because land speculators can put forward planning proposals for almost anything until we have the Plan in place. We need developments that benefit our community, not developments that simply maximise developers' profits.

## LOCAL PLANNING Taking the battle to Whitehall

One outcome of the protest rally against the proposed development at Coate Bridge was the intervention of our MP, Claire Perry, who arranged for a delegation from the town to meet Nick Boles, the Planning Minister.

On 24<sup>th</sup> January Wiltshire Councillors Laura Mayes, Nigel Carter and Richard Gamble accompanied by Tony Sedgwick and Rick Rowlands representing The Devizes Community Area Partnership plus Alistair Cunningham, Wiltshire's Director of Economy and Regeneration met Claire and Nick Boles at Westminster to put our case forward.

Clearly the Minister could not talk about the individual case and the discussion centred on what weight would be given to Wiltshire's Core Strategy, since it was still progressing slowly through the examination by the Minister's own department.

The team took this opportunity to stress that the community had been able to

discuss the contents of the Core Strategy in great detail through DCAP and were satisfied that it was the best possible strategy for the town given the conflicting issues of traffic congestion and the high demand for housing.

Clearly the Government is committed to a house building programme and Mr Boles stressed that Devizes had to take its share. Councillor Mayes confirmed that the Council had identified land suitable for sufficient housing to meet the Core Strategy targets for the next few years and would continue to do so for the duration of that plan (2026).

The group agreed that we had been able to put our case at this high level and had received some valuable pointers as to how best to protect our community from developers anxious to cash in on the planning void before the Core Strategy becomes the official planning guidance. Thanks are due to Claire Perry for affording the town this opportunity.

#### How are we doing?

The Trust for Devizes exists to maintain the quality of the amenities of Devizes and its environs, particularly the built environment. The Trust does not oppose new developments or changes to the built environment but does seek to ensure that they are of a type and quality that enhances the street scene and are of benefit to the community.

Your Committee is very aware that we have recently taken much more of a campaigning stance in opposing developments which, in our view, go against our core objective. But we can only do so if we are acting with the approval of you, our members. So, are we right to pursue this line of activity?

We hold regular 'Socials' which are attended by only a small percentage of our membership. Should we do something different which will appeal to more of our members? How can we attract new members to the Trust?

Do you look forward to receiving your copy of Trust News? If not, what could we do to improve it?

## **Coate Bridge Developments**

In 2011 a Scottish company, Mactaggart & Mickle (M&M), appeared in Devizes seeking opinions on a proposal to build around 350 houses on land to the East of Windsor Drive. That company was told that the local community did not want the development because it would not meet local needs and would add to our problems caused by too many housing estates. Not deterred, they returned last year and launched a second consultation. Why are they here and have they ever laid a single brick outside Scotland? M&M started as genuine house builders in Glasgow but, after the retirement of their founders, new directors seem to have decided that land speculation in England would be more rewarding than building in Glasgow. M&M could obtain planning permission then sell the land, let another company do the building and leave our community to suffer the consequences.

We joined forces with DCAP and CPRE to propose a resolution at the November Area Board meeting opposing the proposal. That resolution enthusiastically approved and led to a public demonstration on The Green in December. Our MP, Claire Perry, arranged a meeting between local representatives and housing minister, Nick Boles, in January to discuss local concerns about the adverse effects of excessive housing estates on Devizes, the way in which the planning system operates and about the Coate Bridge proposal in particular.

Undeterred, M&M have now submitted a formal planning application for a major housing development at Coate Bridge. But, what an application it is! There are 69 documents submitted. They have taken all the concerns expressed during the extensive consultations and used consultants to produce large voluminous

reports in support of their application over the last year or two. This illustrates how the dice are loaded in favour of developers by the planning system. Land speculators can make very large profits from the increase in the value of agricultural land once it has planning permission, so they invest money in expensive consultants and lawyers to get planning permission.

Meanwhile, in comparison, the Wiltshire Council planners have quite limited resources and the time they have to prepare arguments against the application is limited to a few weeks. Even if the Council denies planning approval, the speculators can appeal and a government inspector can approve the development based simply on the particular application and an arbitrary application of planning rules without regard to the longer term consequences for the community. That has happened many times here in Devizes so that our infrastructure is now seriously overstretched by population growth. The speculators are often awarded costs against the Council at an appeal, making the Council even less inclined to oppose the speculators.

So we will have to wait and see what happens at Coate Bridge. Will the delegation to the Minister have any effect? Will it be another case of big bonuses for the speculators and a big loss for the community or will we to see localism begin to have some meaning?



## The Social Organisation of Medieval Devizes

Devizes started life as a Norman ringwork castle constructed by Osmund, Bishop of Salisbury in the 11th century and was located on the boundaries of the manors Rowde, Bishops Cannings and Potterne, on a highly defensive promontory. The streets developed around the castle in a concentric design, visible in any aerial photograph, which is evidence that the town was planned from the start of its development. Historic buildings and archaeology found around Devizes shed light on the social organisation of the medieval world, from the activities of the wealthy to the residences of the destitute.

The planned town suggests that rich, prominent people were present in the medieval period, and archaeological evidence reveals advantaged areas. The castle served as a central point in organisation and by examining the location of sites used by the medieval elite it is clear that important places, such as St John the Baptist's church, the deer park, a hall and other domestic residences are nearer to this focal point within the defences. The sites and objects connected to the poor, ill, criminal and the general public are found further from the centre. The leper hospital, gallows, and St Mary's Church are located either around the edges of the town or outside the town walls.

But why were two churches built at around the same time in the 12 th century positioned in such contrasting locations? The answer to this question may lie in the intended congregation of each building. St John's was used by the

garrison from the castle and its position, so close to the central focus of the town, reflects this. On the other hand, St Mary's was built for congregations of the townsfolk in Devizes, a function highlighted by its removed location on the old boundary. The names of each church also provide a clue, St John being the patron saint for warrior knights whereas Mary, with all the virtuous connotations associated with her, was chosen for the people's church. The locations of the churches provided ease of access to their intended congregations but also marked them out as different from each other.

That Devizes has survived through time shows the importance of the town as a centre of trade and commerce in the region and it provides us with a limited insight into medieval life. It is both a benefit and a problem that Devizes developed into the modern town it is today. On the one hand it shows us the progression the town made, but on the other, deserted medieval towns such as Almondbury in Yorkshire have clearer surviving evidence for social organisation than Devizes has. The answer to the problem of how to obtain evidence about medieval settlements is to examine both deserted medieval towns and surviving ones in the study of medieval organisation.
