#### From the Editor

## CAR PARKING

Wiltshire Council publishes its proposals



In June 2014, the Trust held a public meeting about parking issues affecting the town. As a result of feedback and comments at that meeting, we presented a report to Wiltshire Council as our contribution to the public consultation which was carried out between October and December 2014. The results of that consultation have now been made public. Details are to be found in the minutes of the Environment Select Committee, via this link:

Wiltshire Council now plans to make a number of changes to parking in Devizes. In summary, Sainsbury, Northgate, West Central and Central car parks will change from long stay short stay, with 3 hours maximum. Prices at all car parks will go up except for Station Road where the first hour will go down from 45p to 30p with all day stay at £4. Market Place parking will remain free for 30 minutes.

Commenting on the outcome of the consultation, our traffic and parking expert Tony Sedgwick says, number of the Trust's proposals have been accepted. Station Road being divided into Short and Long Stay is a major improvement, since it will give short-term parkers the opportunity of parking at the town end of the car park, rather than being forced to the far end.

"The price reduction to £4 a day is good news. The overall increase in the hourly charge still keeps Devizes competitive with neighbouring centres. The move to make the Central Car Park short term is good news for shoppers and visitors as it will free up spaces for them.

"Tucked away in the report is one fact which I find alarming. Sheep Street is to have its machine removed and payment will be by mobile phone only. As we have pointed out to the Council, this car park is used by a considerable number of elderly people visiting the Baptist Church for Lunch at One and other community activities. They do not all have mobile phones and probably won't know what to do.

"Whilst I am disappointed that our recommendation to convert the central car park to Pay on Foot (a system which requires the driver to pay at a payment machine before returning to their vehicle) has not been taken forward, I am not surprised. The capital cost would be considerable and would inevitably lead to demands for other towns for this change."

The Trust will monitor how the changes affect life in the town.

### A Road Name to be Proud Of

Tony Sedgewick describes a local hero

At the far end of the Hopton Industrial Estate there is a road named Sergeant Rogers Way. Whilst it is tucked away in a far corner of the town, it is one name we should take notice of.

Sergeant Maurice Albert Windham Rogers fought in the Second World War with the Second Battalion of the Wiltshire Regiment and died at the Battle for Anzio on 3rd June 1944. But it was the manner of his death that made this man, at just 24 years old, worthy of special remembrance. He died in action whilst leading his men in a successful assault on an important enemy target. For that he was awarded the highest honour any serving soldier can achieve, the Victoria Cross.

His citation reads "In Italy, a battalion of the Wiltshire Regiment was ordered to attack high ground held by the enemy. The carrier platoon of the leading company, dismounted were ordered to capture the final objective. They advanced under intense fire and sustained a number of casualties. The platoon, checked by the enemy's wire and the intensity of his machine-gun fire, took cover some 70 vards short of their objective. Serjeant Rogers continued to advance alone, and penetrated 30 yards inside the enemy's defences, drawing their fire and throwing them into confusion. Inspired bv example, the platoon began the assault. Serjeant Rogers was blown off his feet by a grenade, and wounded in the leg. Nothing daunted, he ran on towards an enemy machine-gun post, attempting to silence it. He was shot and killed at point blank range. This N.C.O.'s undaunted determination, fearless devotion to duty and superb courage carried his platoon on to their objective in a strongly defended position. The great gallantry and heroic selfsacrifice of Serjeant Rogers were in the highest tradition of the British

For Maurice Rogers, this was not an isolated incident; he had already

been awarded the Military Medal. This was a year earlier when the Eighth Army was fighting its way through Sicily.

On this occasion Sergeant Rogers' consisting platoon, of personnel carriers was ordered forward to engage the enemy. Whilst doing so, his carrier broke down. Leaving his platoon to hold their position with the disabled carrier, he returned to the Command Post, gave the exact bearings of the enemy's mortar and gun positions and then returned to the fight. However, the order came to withdraw. Unwilling to lose his carrier, Rogers calmly attached tow chains to the stricken carrier despite being under heavy fire. He then towed the carrier back painfully slowly, under attack the whole time. Having got his platoon safely back to base, he immediately removed a track off a burnt out carrier and fitted it to his own, bringing back into immediate service.

Sergeant Rogers was an exceptionally brave man; the type of soldier that inspires others to feats of valour. He never returned to enjoy the peace that he gave his life for – we are the beneficiaries of his sacrifice and are honoured to have a road bearing his name.

#### **Assize Courts: The saga continues**

In the last Trust News, we reported on repair work which has now been carried out by the owners of the Assize Courts. This has prompted many people in Devizes to ask when the building is going to be developed in line with the planning permission which was granted in May 2012. Unfortunately, we are no nearer having an answer to that question.

However, one of the conditions included in the granting of planning permission was that "The works for which Listed Building Consent is hereby granted shall be begun before the expiration of three years from the date of this consent" ie May 2015. There is no longer an option in the Planning Regulations for an extension to the planning permission to be extended for a further 2 years.

Cllr Sue Evans has advised that "The Council is aware, as are the owners, that the current permission expires in May. The Council continues to monitor the condition of the building and to try to work with the owner to seek a long term solution."

Hopefully, by the next edition of Trust News, we will have some more positive news to report.

## **Enforcing planning conditions**

Your Committee scrutinises all planning applications in the Devizes area and comments as necessary. We also follow up on these applications in order to ensure that conditions set by Wiltshire Council are adhered to by the applicant.

A recent example of where things can go slightly awry can be seen here.

The application for a new sign on the undertakers' premises in New Park Street was approved by Wiltshire Council,

subject to conditions which specified the size of the sign. This followed comments made by the Trust about the signage. However, when the sign was put up, it was quite obviously far too large and out of scale for the building. Indeed, it was almost as wide as the building itself.
